Policy and Purpose

Available Uses

The facilities are available for:

- Small groups, churches, and youth groups

- Conferences, worship celebrations, and weddings
- Recreational, sporting events and physical fitness

Approval Requirements

Any requests for usage by an outside group must be approved by the Board of Directors and/or staff. No event will be approved unless the activity and the requesting group/individuals agree with the terms of this agreement and New Life for Youth's [Statement of Faith](#).

PARTICIPANT WAIVER, RELEASE OF LIABILITY & HOLD HARMLESS AGREEMENT

1. Acknowledgment of Risk

I understand and acknowledge that participation in the activities associated with this event may involve inherent and significant risks, including but not limited to: physical injury, permanent disability, paralysis, and death. I understand that while rules, equipment, and personal discipline may reduce these risks, the risk of serious injury does exist.

2. Assumption of Risk

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the RELEASEES or others. I accept full responsibility for my participation in this event and any related activities.

3. Emergency Medical Authorization

I understand that I am solely responsible for any medical costs incurred. In the event of an injury or medical emergency, I authorize NEW LIFE FOR YOUTH ENTERPRISES, INC. and its representatives to:

- Provide first aid
- Seek emergency medical care
- Contact emergency services

4. Release of Liability & Hold Harmless Agreement

6. Compliance With Rules
